Pursuant to the provision under Chapter-VII, Clause-48 of the Himachal Pradesh University of Health Sciences Act, 2017 and on the recommendations of the Inspection Committee and Scrutiny Committee, the Hon'ble Vice-Chancellor, Atal Medical & Research University (AMRU), H.P., is pleased to grant Temporary Affiliation to College of Men-Tsee-Khang Sowa-Rigpa Medical College & Hospital, Dharamshala, District Kangra, HP for the conduct of following course for the Academic Session 2023-24:

The above mentioned institution/college is directed to remove the following deficiencies as early as possible:

College needs to improve IPD facilities.

The above mentioned approval is further subject to the following conditions failing which further action as per the statutes and ordinances of University will be initiated:

- a) Submission of compliance report in respect of above deficiencies alongwith documentary evidence within a period of six (06) months from the date of issuance of this letter.
- **b)** No excess admissions shall be made by the institutions over and above the approved intake by the NCSIM/NCH/AMRU.
- c) The institution/college will not close or start new course(s) or alter intake capacity of seats without prior approval of the NCSIM/NCH/AMRU.
- d) The institution/college shall not charge tuition and fees other than as prescribed by the Govt. of Himachal Pradesh/AMRU.
- e) The institution/college shall comply strictly with the provision made under the Anti-ragging Regulation notified by the UGC/NCSIM/NCH/AMRU/state Govt. for prevention and prohibition of ragging in institution.
- f) The institute/college will follow the admission procedure, University calendar, syllabus, examinations procedure and other norms/standards as laid down by the AMRU.

The committee has also framed the following instructions/guidelines and recommendations for college:

- 1. Increase the number of patients in OPD and IPD.
- 2. The teaching experience must be after obtaining the essential qualification of the respective posts.
- 3. Biometric attendance system must be installed in each institute.
- 4. Sanitary napkin and vending machines must be installed in each institute.
- 5. Deficiencies, if any, in respect of infrastructure, machinery, faculty and staff pointed by NCSIM/NCH and inspectors may be removed at the earliest.
- **6.** Firefighting and biomedical waste management should as per standards.
- 7. All the hostels should have barbed wire fencing and visitor register with chowkidar.
- 8. The Anti-ragging committee should be constituted and should visit the Hostel regularly and document visits, which should be communicated to AMRU every fortnight.
- **9.** All the faculties engaged as warden should be provided rent free accommodation and telephone facility at residence.
- 10. There should be regular and surprise visit by the warden in the hostels and record of that should maintain with the Chief Warden.
- 11. Cleanliness of campus must be maintained.
- 12. Unused machinery if any, in the institution should be put into use and man power recruited and trained for the same.

- 13. Regular meetings o college council, curriculum committee, disciplinary committee, antiragging committee, sexual harassment and any other committee constituted for betterment of institution should be held as per guidelines and the minutes thereof be communicated to the University within a week. Matters of urgent nature must be communicated by fastest mode at the earliest.
- 14. Recreation facility must be available for the students, which should consist of indoor and outdoor games. Coaches for various outdoor games must be engaged on part time basis. Play grounds may be taken on rental basis/request basis where non-existent.
