Grant of Conditional Permission to Men-Tsee-Khang (Sowa-Rigpa), Gangchen Kyishong P.O. Dharamsala Distt. Kangra, Dharamshala, Himachal Pradesh 176215 with 15 seats in UG (BSRMS) course for the academic session 2023-24 under section 28 of NCISM Act, 2020 and relevant regulations thereunder-regarding.

Sir/Madam,

With reference to the subject mentioned above, I am directed to inform you that in pursuance of the provisions of National Commission for Indian System of Medicine Act, 2020, the Indian Medicine Central Council Act, 1970 (48 of 1970) has been repealed with effect from the 11th day of June, 2021. With effect from the said date, the Central Council of Indian Medicine constituted under sub-section (1) of section 3 of the Indian Medicine Central Council Act, 1970 (48 of 1970) has been dissolved. Now, in exercise of the powers conferred by sub-section (3) of the section 1 of the said Act, the Central Government notified that all the provisions of the National Commission for Indian System of Medicine Act, 2020 has been come into force with effect from the 11th day of June, 2021. In view of the above the Central Government constituted the Autonomous Boards with effect from 11th June, 2021 and as per regulation 59 (2) of The National Commission for Indian System of Medicine Act, 2020, Medical standards, requirements and other provisions of the Indian Medicine Central Council Act, 1970 and the rules and regulations made thereunder shall continue to be in force and operate till new standards or requirements are specified under this Act or the rules and regulations made thereunder.

Further, the provisions of concerned regulations which are inconsistent with the provisions of NCISM Act 2020 shall not be applicable.

- Further, to assess the available facilities of teaching, non-teaching, Hospital staff, practical training and other infrastructure facilities at your college namely Men-Tsee-Khang (Sowa-Rigpa), Gangchen Kyishong P.O. Dharamsala Distt. Kangra, Dharamshala, Himachal Pradesh 176215 inspection of your College was conducted on 09.05.2023 and 10.05.2023 on hybrid mode as a part of annual visitation by the visitation team of Medical Assessment and rating Board, NCISM to process the Conditional permission with 15 seats in UG (BSRMS) course for the academic session 2023-24 under Section 28 of NCISM Act 2020 and relevant regulations thereunder.
- Further, the visitation report and all other related documents were assessed in terms of enforced regulation namely, the "Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Sowa-Rigpa Colleges and attached Hospitals) Regulations, 2017", and provisions under the NCISM Act, 2020 and relevant Regulations there under. On examining the same certain deficiencies were observed by the Medical Assessment and Rating Board for Indian System of Medicine (NCISM).
- As per the direction of President, Medical Assessment and Rating Board for Indian System of Medicine (NCISM), the assessment report was placed in the 46nd Board meeting of Medical Assessment and Rating Board for Indian System of Medicine (NCISM) held on 07.07.2023. On careful examination of the assessment report, it is found that, there is a shortcoming of average bed occupancy in the hospital. Hence the Board decided to grant an opportunity of clarification to the college. In response of the same a clarification has been received from your college vide letter no: MTK/D-COL/F4/NCISM-MARB/2023-4 dated 15.07.2023. After analyzing the clarification it has been decided to issue the Conditional permission with 15 seats in UG (BSRMS) course under Section 28 of NCISM Act 2020 for the academic session 2023-24.
- Therefore, Conditional Permission is granted to the Men-Tsee-Khang (Sowa-Rigpa), Gangchen Kyishong P.O. Dharamsala Distt. Kangra, Dharamshala, Himachal Pradesh 176215 with 15 seats in UG (BSRMS) course under section 28 of NCISM Act, 2020 for the academic session 2023-24, subject to the condition that college is fulfill the following requirement :-
 - As per MSE (Sowa-Rigpa) 2022 regulation 4 (4) the counselling for admission to Bachelor of Sowa-Rigpa Medicine and Surgery Programme shall be conducted by Sowa-Rigpa Central Counselling Committee (SRCCC) constituted by the National Commission for Indian System of Medicine in this behalf and in this process the policy on reservation of the concerned state (if any) in the admission of Sowa-Rigpa under-graduate Programme shall be considered.
- Admissions made in violation of the above conditions will be treated as invalid and action will be initiated under NCISM Act & Regulations thereunder.

- Discrepancies, if any, may be immediately brought to the notice of Medical Assessment and Rating Board for Indian System of Medicine, NCISM.
- The following requirements should be fulfilled by the college by 31st December, 2023 to get permission for the session 2024-25:
 - All the requirements of Minimum Standard of infrastructure and teaching & training facilities as specified in Regulation 3 of the "Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Siddha Colleges and attached Hospitals) Regulations, 2016;

All the requirements of the Indian Medicine Central Council (Minimum Standards of Education in Indian Medicine) (ii) Amendment Regulations, 2016 (for Siddha);

All the requirements, under the provisions of the NCISM Act-2020 and relevant Regulations, made thereunder (iii) should be fulfilled in toto;

- The fulfillment of the conditions given above may be made within the time period specified and compliance report should be submitted by the college to President, Medical Assessment and Rating Board for Indian System of Medicine. The Medical Assessment and Rating Board for Indian System of Medicine will verify that the conditions have been fulfilled for considering the permission for the academic session 2024-25.
