Grant of Conditional Permission to Men-Tsee-Khang (Sowa-Rigpa), Gangchen Kyishong P.O. Dharamsala Distt. Kangra, Dharamshala, <u>Himachal Pradesh 176215</u> for intake capacity of 15 seats in UG (BSRMS) course, for the academic session 2022-23, under Section 28 of NCISM ACT 2020 and relevant regulations thereunder-regarding.

Sir/Madam,

With reference to the subject mentioned above, I am directed to inform you that in pursuance of the provisions of National Commission for Indian System of Medicine Act, 2020, the Indian Medicine Central Council Act, 1970 (48 of 1970) has been repealed with effect from the 11th day of June, 2021. With effect from the said date, the Central Council of Indian Medicine constituted under sub-section (1) of section 3 of the Indian Medicine Central Council Act, 1970 (48 of 1970) has been dissolved. Now, in exercise of the powers conferred by sub-section (3) of the section 1 of the said Act, the Central Government notified that all the provisions of the National Commission for Indian System of Medicine Act, 2020 has been come into force with effect from the 11th day of June, 2021. In view of the above the Central Government constituted the Autonomous Boards with effect from 11th June, 2021 and as per regulation 59 (2) of The National Commission for Indian System of Medicine Act, 2020, Medical standards, requirements and other provisions of the Indian Medicine Central Council Act, 1970 and the rules and regulations made thereunder shall continue to be in force and operate till new standards or requirements are specified under this Act or the rules and regulations made thereunder.

Further, the provisions of concerned regulations which are inconsistent with the provisions of NCISM  $Act\ 2020$  shall not be applicable.

- 1. Further, your institution, namely Men-Tsee-Khang ( Sowa-Rigpa), Gangchen Kyishong P.O. Dharamsala Distt. Kangra, Dharamshala, <u>Himachal Pradesh 176215</u> was assessed on virtual mode as part of Annual visitation on 08-09-2022, by the visitation team of Medical Assessment & Rating Board for Indian System of Medicine (NCISM), to assess the available facilities of teaching and practical training for intake capacity of 15 seats in UG (BSRMS) course, for the academic session 2022-23 under Section 28 of NCISM ACT 2020 and relevant regulations thereunder.
- 2. After analyzing the assessment report, the matter was placed in the 8<sup>th</sup> Board Meeting of Medical Assessment & Rating Board, NCISM. The Board, on examining the assessment report in terms of Regulation 3 of the "Indian Medicine Central Council (requirement of minimum standard for Undergraduate Sowa-Rigpa Colleges & attached Hospitals) Regulations, 2017, provisions under the NCISM Act, 2020 & relevant regulations thereunder, it was found that your College was not fulfilling notified & approved criteria for issuing Conditional Permission for 15 seats in UG (BSRMS) course. Further the board decided to grant an opportunity of hearing to your college. Accordingly the minutes of the Hearing Committee was placed in the 12<sup>th</sup> Board Meeting of Medical Assessment and Rating Board, NCISM. After analyzing the Hearing Committee Report, it was found that your college is fulfilling notified & approved criteria for issuing Conditional Permission for 15 seats in UG (BSRMS) course for the academic session 2022-23.
- 3. Therefore, it has been decided by the President, Medical Assessment and Rating Board for Indian System of Medicine (NCISM) to grant Conditional Permission to Men-Tsee-Khang (Sowa-Rigpa), Gangchen Kyishong P.O. Dharamsala Distt. Kangra, Dharamshala, <u>Himachal Pradesh 176215</u> for conducting 15 seats in UG (BSRMS) course, for the academic session 2022-23, subject to following condition:
  - i. The college shall submit an undertaking in the form of affidavit duly notarized within one month from the date of issue of the letter, explaining the details of providing EPF and ESI facilities to the teaching, non-teaching staff of the Colleges/Hospitals and regularly paying fee same as per the provisions of Employees' Provident Funds and Miscellaneous Provident Act, 1952 & ESI Act, 1948 and relevant Rules and Regulations.
- Admissions made in violation of the above conditions will be treated as invalid and action will be initiated under NCISM Act & Regulations thereunder.

- Discrepancies, if any, may be immediately brought to the notice of Medical Assessment and Rating Board for Indian
- The following requirements should be fulfilled by the college by 31st December, 2022 to get permission for the
  - All the requirements of Minimum Standard of infrastructure and teaching & training facilities as specified in Regulation 3 of the "Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Sowa-Rigpa Colleges and attached Hospitals) Regulations, 2017; (ii)

All the requirements of the Indian Medicine Central Council (Minimum Standards of Education in Indian Medicine) Amendment Regulations, 2017 (for Sowa-Rigpa);

- All the requirements, under the provisions of the NCISM Act-2020 and relevant Regulations, made (iii) thereunder should be fulfilled in toto;
- The fulfillment of the conditions given above may be made within the time period specified and compliance report should be submitted by the college to President, Medical Assessment and Rating Board for Indian System of Medicine. The Medical Assessment and Rating Board for Indian System of Medicine will verify that the conditions have been fulfilled for considering the permission from the academic session 2023-24.
